Property owner hereby agrees that upon connection to the system, he/she will pay the usual and customary fee commencing at the time that said connection becomes operational. Connection must be made within twelve (12) months. Permit will be void after twelve (12) months without refund of initial payment.

Property owner assumes all responsibility for utility billing and tap fees. If responsibility is assigned to a renter, all unpaid bills at time of departure will be re-assigned to the property owner. If connection is abandoned, regular monthly fees will be assessed. The owner/s agree to comply with the ordinances of the Town of LaGrange pertaining to the said system and its operation, and agree that this document shall constitute a covenant running with the property.
